- 3. Sealed Quotation must be submitted to the office of Kankai Municipality, Nepal on or before **above mentioned date and time**. Documents received after this deadline shall not be accepted.
- 4. The sealed Quotation shall be opened in the presence of Bidders' representatives who choose to attend **above** mentioned date and time in the office of Kankai Municipality.
- 4 Quotations must be valid for a period of 45 days after opening of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting as specified above, which shall be valid for 75 days after opening of the Sealed Quotations.
- If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the quotation validity and quotation security validity shall be recognized with effect from the original quotation submission deadline.
- 6 Kankai Municipality reserves the right to accept or reject, wholly or partly any or all the quotation without assigning reason, whatsever. In the case of discrepancies or error in quotation documents, quotation notice or any other documents, Kankai Municipality reserves the right to amend and correct at any time.
